Whereas, **School Sports Promotion Foundation** is a sub unit of The Gurukul Trust, registered under the Law, a non-profit philanthropic trust already working with schools across the country, hereafter known as **SSPF** and represented by its chairman Mr. Om Pathak.

And Whereas **SSPF** has entered into an MOU with **Sports Authority of India** and also has received assurance of support from the **Department of Sports**, Government of India.

And Whereas **SSPF** has already launched **National Talent – Search & Nurture program (NTS & NP)** across India in partnership with **Sports Authority of India**.

DEAL TERMS

- A. **SSPF** is the rights holder of the **NTS & NP** being held in India as per the schedule A.
- B. This is a formal written agreement with regard to broadcast rights of **NTS & NP**.

NOW THEREFORE, in consideration of the premises and mutual agreement hereinafter set forth, the parties agree as follows: -

1. **EVENT: NTS & NP 2015** events are as per the schedule A. For subsequent years, **SSPF** will provide the schedule by the month of March / April of that year.
2. **LICENSED PERIOD**
 - 2.1 The rights granted to Doordarshan shall be exclusive and commence on the date of the signing of this Agreement. Doordarshan shall have perpetual rights of the events.
 - 2.2 This agreement shall be valid for a period of 3 years from the date of signing the agreement.
3. **LICENSED TERRITORY:** The rights are granted for the territories as per the transmission mode of Doordarshan.

4. LICENCE TERMS & CONDITIONS

- 4.1 All events covered live will be charged as per the cash outflow rates of DD Sports which are most minimum for live coverages. For all recorded coverages there will be no charges. However, the organizers shall provide transport, accommodation and all logistics support to the production team of DD Sports.
- 4.2 Doordarshan will not charge any slot fee for the telecast of NTS & NP programmes.
- 4.3 Doordarshan will promote the events on DD Sports.
- 4.4 SPPF agrees to acknowledge, display and promote DD Sports as its media partner in all its verticals.

5. GOVERNING LAW AND ARBITRATION

- 5.1 This Agreement shall be governed by and construed in accordance with the laws of India.
- 5.2 In the event of any dispute related to the interpretation or rights or liabilities arising out of this agreement, the same shall, at first instance, be amicably settled between the parties. If any dispute is not settled amicably, the same shall be referred to the Sole Arbitrator to be nominated by the CHIEF EXECUTIVE OFFICER, PRASAR BHARATI (BCI). The award given by the Arbitrator shall be final and binding on the parties. The venue for Arbitration shall be in New Delhi.
- 5.3 The applicable law governing the Arbitration proceeding shall be the provision of Arbitration & Conciliation Act, 1996 and laws of India and the Courts of Delhi shall have the exclusive jurisdiction.
